 - KL East Mall: 10:00am, 3 November 2025 - 3:00pm, 3 January 2026
 - Elmina Lakeside Mall: 10:00am, 17 November 2025 - 9:30pm, 23 December 2025
 - KLGCC Mall: 10:00am, 15 November 2025 - 9:30pm, 4 January 2026
- Contestants can drop their receipt(s) at the Concierge Counter with the following minimum spending within the same day:
 - KL East Mall: RM500 in a single receipt
 - Elmina Lakeside Mall: RM500 in a maximum of two (2) same-day receipts
 - KLGCC Mall: RM500 in a single receiptLucky draw entry tickets are not given in accumulation for every RM500 spent.
Example: Total receipt amount RM1,200 - Entitled to redeem one (1) lucky draw entry ticket only.
- Redemption of the lucky draw entry tickets is only valid for purchases made within the same day, and Contestants are limited to one (1) redemption per day.
- For the purpose of meeting the minimum spending requirement, combining receipts or transaction records from different Participating Malls is strictly prohibited and invalid.
